# EMPLOYER REIMBURSEMENT PLAN AUTHORIZATION FORM SPRING 2025

Students whose employers will reimburse them for educational expenses may qualify for the University’s Employer Reimbursement Plan. This plan allows students to register for classes and postpone tuition payment until **June 5, 2025**. The processing fee of \$100 must be paid to Nelnet Campus Commerce the University’s payment plan provider. The following conditions apply to this program:

1. The student’s employer must be a **third party other than the student** and agree prior to registration to pay for authorized tuition and fees.
2. Student must have this form completed by the employer and submit it to Student Accounting Services by respective payment due date. The employer representative signing this form must attach a business card – if card is not available, a signed approval email from the authorized officer will be sufficient.
3. Student with less than 100% tuition and fee reimbursement must pay the uncovered amount in full at the time of registration or have another payment option set up.
4. Student must sign up and budget the reimbursable amount with Nelnet Campus Commerce through myGGU or at <https://online.campuscommerce.com/signin/4NFLY> and pay a \$100 processing fee.
5. *A payment reminder will be emailed to student 4 business days prior to the payment due date. The student is responsible for payment, in full of all amounts(s) due under this plan on June 5, 2025, whether or not the amount has been paid by the employer. If the employer refuses, for any reason, to reimburse the student, the student remains responsible for payment of all charges. Payment must be made to Nelnet (NOT directly to GGU).*
6. Failure to pay by the due date will result in a late charge of \$40 and a 1.5 percent finance charge per month commencing after 30 days past due. In addition, the late payment may result in the loss of the student’s eligibility to participate in the University’s payment plans.
7. The student must be in good financial standing with the University.
