#### PREPARING FOR THE WASC ACCREDITATION VISIT

Golden Gate University is preparing for a significant milestone in its accreditation process. Information about the visit will be disseminated through the Faculty Newsletter and elsewhere as the accreditation visit nears.

#### Key Updates:

- Institutional Report Submitted: GGU submitted its Institutional Report to WSCUC in October 2024, highlighting accomplishments and identifying areas for improvement. Accomplishments include significant progress in enrollment growth, advancements in shared governance and DEIB, what else? The comprehensive report is available here:
- Document Requests: The WASC Visiting Team reviewed the Institutional Report in December and recently requested additional materials, which GGU is currently compiling and will deliver to the Visiting Team in February.
- Campus Visit: The Visiting Team will be on campus April 9–11, 2025. A detailed schedule of meetings will be shared soon. Profiles of the Visiting Team members are available .

Through the self-study process, GGU identified priorities for improvement. Key focus areas include:

<u>Fall Term Academic Calendar.</u> All important dates: beginning and end of terms, holidays, and when grades are due can be found on the calendar.

#### FALL-TERM 2025

The Registrar's Office Self-Service web application for faculty, allows users to interact directly with GGU's student information system, Colleague. Via the application, faculty can perform the following tasks:

- View their class rosters and send email messages to students.
- Create sign-in sheets for in-person class meetings.
- Record attendance for class meetings, either present on-site or attended remotely.
- View their class rosters and send email messages to students. Create sign-in sheets
- Drop students due to non-attendance during the first two weeks of the term.

\*Note: if warranted, you will have to continue to submit "At-Risk Concern" and/or

"Allegations of Academic Dishonesty" reports via the GGU4YOU course roster.

The Self-Service icon will appear on your myGGU "SSO Resources" pane automatically. If you do not see the icon by the first day of the term, please contact the Registrar's Office at records@ggu.edu.

#### **Recording Attendance**

• Faculty are required to post attendance in faculty self-service. The Self-Service resource is to be used for recording attendance and final grades. Attendance must be recorded for all students who attend in-person and online-synchronous class meetings. It's important for attendance to be recorded during, or immediately after, each class meeting.


**Requests to Falsify Attendance Records** 

• If students ask that you falsify their attendance records, either by recording attendance for dates when they were absent, or by recording that they attended in-person rather via web conference, this would be considered a violation of GGU's <u>Student Code of Conduct</u>. If this situation arises, please contact the Dean of Students at divofstudentsuccess@my.ggu.edu and provide relevant information such as the course you are teaching, students' names and ID numbers, and their specific requests to falsify their attendance records.

Make-Up In-Person Class Meetings

• You may not offer make-up in-person class meetings for VA education benefits recipients only. These students must attend in-person class meetings that have been formally scheduled with the Registrar's.

IGGU 's attendance policy requires that all students must attend every in-person session for courses with HSF and SF sections, regardless of military or other status. We received many questions from faculty regarding attendance policies and recording attendance. This short FAQ sheet is designed to address the common questions we've received.

Golden Gate University's Attendance Requirements

• Every term the schools schedule courses that have one or more in-person meeting sessions. These courses are identified with instructional codes HSF and SF. Student registered in these courses are required to attend every class meeting in-person and should not be attending any of the course meetings remotely.This requirement applies to all students in these course sections regardless of military or other statuses.Should you have questions regarding GGU's attendance requirements, please contact your program director or school dean. **Questions about VA Residency Requirements** 

- Veteran students are informed each term about what they need to do to meet the VA residency requirements. These requirements are complicated, and it is important that students are directed to someone who can best respond to their questions. Students who have questions about their residency requirements should contact VA@ggu.edu. Student can also meet with a GGU VA Certifying Official to discuss what options are available to them.
- If a VA student indicates that they are not able to attend the in-person meeting date(s) for your course, do not offer any alternate dates that are not already published on GGU's <u>Course Schedule</u> page. It's natural for us to want to accommodate students, but making exceptions puts the student at-risk of not receiving their benefits

There are many ways to communicate to someone about students who are at-risk. The term at-risk is used to identify students who are not meeting the expectations of your class because they've stopped attending, participating, submitting assignments, have shared information with you about dropping out, they've told you they can't continue the class for various reasons or the student has shown concerning behavioral issues. Violating Golden Gate University's <u>Academic Policy</u> also puts the student at-risk.

These are just some examples of students who have shown at-risk behaviors. you may have experienced other situations where you were concerned about the student's ability to be successful. If at any time in the term you believe a student is at-risk, the best way to communicate your concerns is to submit an at-risk report. It's always best practice to submit the at-risk report as soon as possible

Reporting at-risk students is easy. Log into the <u>MyGGU</u> portal, and click on GGU4U and then go to your course roster found under "Course Administration." Simply locate the student you are concerned about and to the right of their name is the "AT-RISK" Reporting button.

#### eLearning has a new video platform - Echo360!

In addition to creating and uploading course videos, Echo360 offers several engagement tools to promote active learning and interaction in your courses. Some of these engagement tools include:

- •Polling: Create polls to check comprehension and encourage participation during lectures.
- Q&A: Allow students to ask questions anonymously or publicly, promoting a collaborative learning environment.

- Hybrid (In-Person/Online) (Section Code: HSF): Instruction includes a combination of in-person and online (synchronous or asynchronous) coursework. At least 20% of the instruction time must include in-person class meetings. In-person class meetings cannot be attended remotely. In-person and synchronous online class meeting dates and times are listed on the schedule and course syllabus. Satisfies "in residence" requirements for Veteran Affairs Education Benefits and residency requirements for international students (F-1 Visa holders).
- In-Person (Section Codes: SF): Instruction is delivered through in-person class meetings. Satisfies "in residence" requirements for Veteran Affairs Education Benefits and residency requirements for international students (F-1 Visa holders).
- Online-Asynchronous (Section Code: C): Instruction is delivered primarily through asynchronous coursework but may include optional synchronous online class meetings. Does not satisfy "in residence" requirements for Veteran Affairs Education Benefits. Does not satisfy residency requirements for international students (F-1 Visa holders).
- Online-Synchronous (Section Code: WC): Instruction is delivered primarily through live online class meetings but may include asynchronous coursework. Does not satisfy "in residence" units for Veteran Affairs Education Benefits. Does not satisfy residency requirements for international students (F-1 Visa holders).
